



Instructions – All International Applicants Must Mail this Completed Form to the International Student Services Office

The purpose of this form is to certify that you have the sum of \$49,996 USD for your first year of study at Soka University of America. This could be a combination of a Soka Merit Scholarship, Soka Opportunity Scholarship, Soka Access Loan and personal funds. A Certificate of Eligibility (Form I-20) for Nonimmigrant (F-1) Student Status cannot be issued unless this form is completed and all bank statements are provided. **Please submit a copy of your current passport along with this form as soon as your financial aid process is completed to the International Student Services Office by June 1st, 2018.**

It is important that you make copies of this completed form and required documents before returning them to Soka University, as you will need to show proof of adequate funding to U.S. Consular officials when applying for a visa.
